Waiver & Release of Liability

PADDLER'S NAME: _____

In consideration of being allowed to participate in any way in Hawaii Adaptive Paddling Association and its member organizations athletics/sports programs, and related events and activities, the undersigned paddler or, if applicable, custodial parent or guardian (hereinafter "Paddler"):

1. Agree that prior to participating, Paddler will inspect the facilities and equipment to be used, and if Paddler believes anything is unsafe, Paddler will immediately advise a Hawaii Adaptive Paddling Association authorized representative of such condition(s) and refuse to participate.
2. Acknowledges and fully understands that Paddler will be engaging in activities that involve risk of serious injury, including permanent disability and death, and severe social economic losses which might result not only from his/her own actions, inactions or negligence, but the action, inaction or negligence of others, the rules of play, or the condition of the premises or of any equipment used. Further, that there may be other risks not known to Paddler or Hawaii Adaptive Paddling Association which are not reasonably foreseeable at this time.
3. Assumes all the foregoing risks and accept personal responsibility for the damages following any such injury, permanent disability or death.
4. Releases, waives, discharges and agrees not to sue Hawaii Adaptive Paddling Association, its member associations, its affiliated clubs, their respective administrators, board members, directors, agents, coaches and other volunteers or employees of the organization, other participants, sponsoring agencies, sponsors, advertisers, and if applicable, owners and leasers of premises used to conduct the event, all of which are hereinafter referred to as "Releases," from demands, losses and damages on account of injury, including death or damage property, caused or alleged to be caused in whole or in part by the negligence of the Release or otherwise.
5. Paddler hereby grant Hawaii Adaptive Paddling Association permission to interview Paddler and/or to use Paddler's likeness in photograph(s)/video in any and all of its publications and in any and all other media, whether now known or hereafter existing, controlled by Hawaii Adaptive Paddling Association, in perpetuity, and for other use by Hawaii Adaptive Paddling Association. Paddler will make no monetary or other claim against Hawaii Adaptive Paddling Association for the use of the interview and/or the photograph(s)/video.
